What is the WASM VET Cluster?

Welcome to the WASM VET Cluster, where students in the Wimmera Southern Mallee region gain access to high quality vocational education and training through the VET Delivered to Secondary Students (VDSS) program. Qualifications are offered by a range of Registered Training Organisations (RTOs) and are designed to give young people a head start on their career pathways.

The WASM VET Cluster is a partnership between regional secondary schools, RTOs, and the Wimmera Southern Mallee LLEN.



What is VET?

Vocational Education & Training (VET) programs are nationally recognised vocational (work) certificates. A VET course provides specialised industry training that focuses on practical skills and knowledge for a specific career. VET courses are designed with industry professionals to ensure training meets current job demands and are approved by the Australian Skills Quality Authority (ASQA). Each VET course is broken down into 'units of competency'. Units of Competency are a set of skills that students will learn as they complete their course. They are like the 'building blocks' towards obtaining the qualification.

What is VDSS?

Vocational Education and Training Delivered to Secondary Students (VDSS) is a program that facilitates senior secondary students to undertake a VET course while still at school. The design of VDSS means that the VET course is endorsed for recognition in the students preferred senior secondary pathway i.e. Victorian Certificate of Education (VCE), Vocational Major (VM) or the Victorian Pathway Certificate (VPC). The program is available to Year 10, 11 & 12 students. Students must have their school's approval to enrol.



What will I get?

A nationally recognised qualification upon successful completion of the program. Or students may receive a Statement of Attainment for Units of Competency successfully completed if the full certificate is not completed. The qualification and/or units of competency successfully completed may pathway directly into further education and training upon leaving school or successfully obtaining a school-based apprenticeship or traineeship.

What will it cost?

Currently course costs are subsidised through the Department of Education and your school through the Victorian Training Guarantee. Subsidies may also extend to the cost of transport to and from the RTO. Students may have to pay some material or book fees depending on the course. Note that the fees are subject to change without notice.


How much work is there in VET?

Different VET courses have different levels of workload. Whilst VET programs incorporate a high level of hands-on-learning, they also include significant theory-based training. Some VET courses also require higher levels of literacy and/or numeracy. Students should always talk to their schools' careers practitioners and their family before enrolling. If a student is eligible for funding to provide education support within their school, the school will also organise education support within the VET class.

Why should I do a VET?

You should talk to your school and ensure VET is the right option for your pathway. There are many benefits to undertaking a VET including:

- *Practical Skills:* Gain hands-on experience and practical skills directly applicable to real-world jobs
- *Early Career Start:* Start building a career pathway while still in school, giving you a head start in the workforce
- *Industry Connections:* Build connections with industry professionals and potential employers through work placements and training
- *Increased Employability:* Improve your job prospects with nationally recognised qualifications that make you stand out to employers
- *Flexible Learning:* Enjoy a variety of learning options that can be tailored to your interests and career goals
- *Pathway to Further Education:* Use your VET qualifications as a stepping stone to higher education or advanced training opportunities.



How does VET fit in with my school certificate?

VCE: Vocational Major, (VCE: VM)

VCE: VM is a two-year vocational and applied learning program integrated into the VCE. It is mandated that students studying the VCE: VM complete 180 nominal hours of a certificate II or above. This will contribute 2 VET credits towards a student's program.

Victorian Pathways Certificate, (VPC)

Students studying VPC can include a VET program however it is not mandated.

VCE

Some VET programs are approved by the Victorian Curriculum and Assessment Authority (VCAA) and can provide credit towards the student's Australian Tertiary Admission Rank (ATAR), via either scored assessment or a 10% increment (see below).

Scored Assessment

Courses that offer a scored assessment will contribute directly to the student's ATAR either as one of the primary four studies, or as a fifth or sixth study. Students undertaking scored assessment as part of their VET course will be assessed via school-assessed coursework and an end-of-year examination set by the Victorian Curriculum and Assessment Authority, (VCAA). Students must be registered for scored assessment with their RTO.

10% Increment

Where a VCAA approved course does not offer scored assessment but does include a Units 3 & 4 sequence, the student is eligible to receive an increment of 10% of their average primary four ATAR subject scores if they successfully complete the Units 3 & 4 sequence.

All options should be discussed with your school to ensure alignment with your career pathway.

Unique Student Identifier (USI)

All students doing nationally recognised training need to have a Unique Student Identifier (USI). A USI is a reference number made up of numbers and letters.

Creating a USI is free. It creates a secure online record of your nationally recognised training that you can access anytime and anywhere, and it's yours for life. The USI is linked to the National Vocational Education and Training (VET) Data Collection, and this means an individual's nationally recognised training and qualifications gained anywhere in Australia, from different training organisations, will be kept all together. The USI will let students easily access secure digital transcripts of their achievements and gives more control over their VET information.

Application for a USI is done online, by going to www.usi.gov.au. You will need a USI before applying for VET.

Guidelines and Expectations

VET is considered a higher education program and students, in consultation with their parent/guardian(s) and teachers, should discuss their readiness to undertake a VET course. Students are expected to:

- Sign a Code of Conduct
- Have high attendance
- Be punctual and limit missing class time
- Submit assessments and work tasks on time
- Be respectful of trainers and other students
- Abide by the procedures and policies for their Registered Training Organisation
- Ensure the practice of occupational health and safety as directed.

Behaviour and at-risk procedures will be applied in accordance with RTO and WSM VET Cluster operational policies and students may be withdrawn from their nominated program if expectations are not met.

VET Enrollment Process

EXPLORE

Explore the wide range of courses offered via the WSM VET Cluster website. Look at the type of work, course requirements, and potential career pathways.

CONSULT

Consult with your school's VET Coordinator or Careers Advisor on the suitability of the course and how it will align with your senior pathway. Your coordinator will submit an expression of interest to the cluster coordinators.

USI

Obtain or locate your Unique Student Identifier (USI) number. This can be obtained through the link: www.usi.gov.au.

APPLY

If you are accepted into a program, your VET Coordinator will send you a link to complete the online application form. You, and a parent/guardian, must complete this as soon as possible to reserve your spot in the course.

RTO

Once you have completed and submitted your application, the details are passed onto the Registered Training Organisation (RTO) who deliver the course. The RTO will contact you with further instructions and information.

LLN

The RTO will ask you to complete an LLN (Language Literacy and Numeracy) test which is a series of questions to help ensure your level of understanding and knowledge in core areas.

INDUCTION

You may be asked to attend an induction day. An induction day is like a 'VET Practice Day'. You will be asked to attend classes, participate in programing, and meet your Trainers, other relevant staff and classmates.



AGRICULTURE

AHC20122 Certificate II in Agriculture

The AHC20122 Certificate III in Agriculture is delivered both on and off the job in a partnership arrangement between Longerenong College, businesses and participating schools and normally takes two years to complete.

The aim of the program is to provide participants with skills in a range of industries which will lead on to further study or will enhance opportunities for employment in a range of industries including intensive animal production, broadacre cropping and agribusiness.

As a part of our Agriculture package we also include a selection of specialised skills units giving students a bonus pack of units at the conclusion of their course.

The Certificate II in Automotive Vocational Preparation is a work-ready pre-employment program designed to meet the needs of students wishing to pursue a career in the automotive industry. This program aims to enable students to develop a defined range of skills appropriate to entry-level positions in the automotive industry and to apply known solutions to a limited range of predictable problems associated with an understanding of basic automotive technologies.

Contribution Towards VCE: VM

A certificate II or above VET Course is mandatory for students studying VCE:VM. 180 nominal hours or above = 2 VET credits

Contribution Towards VPC

Every 90 nominal hours of VET = 1 unit of credit.

Contribution Towards VCE

Students will be eligible for two or more units at Units 1 and 2 level and a Units 3 and 4 sequence.

ATAR Contribution

Students who receive a Units 3 and 4 sequence will be eligible for an increment towards their ATAR (10 percent of the fourth study score of the primary four studies).





VET TRANSPORT

General Information:

Rural and regional bus transport runs from most areas in the Wimmera, Southern Mallee and Central Grampians to Horsham every Wednesday to support students getting to their nominated VET program. Thanks to the continued support of the Department of Education, this service is offered free to students attending VDSS in 2025.

Most buses arrive and leave from the Horsham College Bus Exchange. For students attending Longerenong, there is an additional service which operates from the Bus Exchange to and from Longerenong College. For students attending from the Central Grampians Region, the bus will arrive and leave from the Roberts Avenue Bus Station with a public connection bus between Horsham College (Federation University end) and Roberts Avenue in the afternoon if required.

Students are responsible to ensure they are at the appropriate site in time to catch their bus. Buses cannot wait for late students and parents/guardians may be asked to pick-up a student if the student misses their bus.

Students are reminded that appropriate behaviour is expected at all times at the bus exchange, on buses, and whilst walking to connecting buses. All bus services supply Childsafe policies and Working with Children Checks to the cluster. Some buses are considered public buses and may have additional passengers from within the broader community. There is limited formal supervision and students are responsible for their own actions. Any concerns, incidences, or questions should be directed to your school's VET Coordinator who follow-up with the Transport Coordinators if necessary.



WORK PLACEMENT

What is Work Placement?

Work placement refers to a period of structured, supervised work experience in a real workplace environment. Work placements are designed to provide students with hands-on experience, allowing them to develop practical skills, gain industry insights, and understand workplace expectations.

Work placement can be an essential component of many VET courses where students apply the knowledge and skills learned in their training to actual work situations. In some circumstances, work placement may be compulsory for your chosen VET course.

Depending on your pathway, your work placement may be recognised against your senior secondary certificate.

Why Should I do it?

- develop practical skills and build contacts
- develop confidence in the workplace
- develop personal skills and maturity
- gain experience to include in your resume
- obtain an industry-based reference
- learn about industry practices and procedures
- apply skills and knowledge obtained in the classroom to the work environment.
